Call to Order, Establishment of Quorum	<i>The Principal called the meeting to order at 5:31 pm. There were 13 members present, which constituted a Quorum.</i>
Introductions	<i>Principal asked members to introduce themselves and state their role on the School Site Council. The Secretary noted the year of the elected term for each member as first or second.</i>
Review and Approval of Minutes	<i>The minutes from the 5/20/20 meeting were reviewed and approved with no changes. Mr. Sanger made the motion, Mr. Heffernan seconded the motion, and all council members voted “aye” in a voice vote.</i>
Review Roles and Responsibilities <ul style="list-style-type: none"> <li>• Bylaws</li> </ul>	<i>Principal Christmas reviewed the roles and responsibilities of the SSC. The main role of the SSC is to develop, review, update and approve the School Plan. The council reviewed the Bylaws, and decided that no amendments were needed for this school year.</i>
Election of Officers of SSC	<i>The council elected the following positions from the members: Angee Wangsgard, Chairperson; Jasjeet Kaur, Vice-Chairperson; Ashley Leddy, Secretary. All positions were elected by voice vote unanimously. The Secretary noted the officers on the official roster.</i>
Review and update the Site LCAP actions and align and approve budgets: <ul style="list-style-type: none"> <li>• Input on the parent involvement funds</li> <li>• Vote on approval of changes</li> <li>• Signatures obtained to recommend changes to the Board of Education</li> </ul>	<p><i>The Site LCAP actions were reviewed and Principal Christmas explained changes that have been made; such as: funding added to FACE and Latino Literacy Project (help provide translation services for families). The balance will be placed in a section of the LCAP for technology (Chromebook/teacher technology/programs) to support during Distance Learning.</i></p> <p><i>Mr. Heffernan called a motion to approve the changes as written. Mr. Pale seconded the motion. The members of the council approved the changes by an unanimous voice vote. Principal Christmas explained the next steps, which includes signing the document at the school site within the next week and turning in to the District Office. Principal Christmas will email those who need to come in for signing the document.</i></p>
